CURRENTLY – LOOKING AT HOSPITAL QUALITY

- Goal is to look at price and quality information to make informed decisions
 - Quantros provides line of site to 40 hospital clinical categories and provides quality reliability.
 - Used by some hospitals in Indiana to report/improve their quality
 - Obtained 20 Forum sublicenses provided to employers
 - MPIRICA exploring
 - Others?



CURRENTLY – LOOKING AT RATIONALE POLICY

 Informing Health Policy – Invited to meet with Al Hubbard and his team along with numerous other Forum stakeholders.

- Their final report to be published soon.
- Meeting with state legislators and other healthcare stakeholders only upon their request.
- Several bills will be introduced in the 2020 legislative session...going to be wild!




DEBUNKING RUMORS

1. States that have Certificate of Need have lower hospital prices...wrong....NO Correlation...see slide.

- 2. States that have higher state public health funding have lower hospital prices...also wrong....NO correlation....see slide.
- 3. States that have better health of their population have lower prices....WRONG again and doesn't even make sense....see slide and case.




Total Hospital Commercial Prices & Certificate of Need: No Correlation

CASE EXAMPLE

Bob is a Hoosier who is on a commercial health plan and is not so healthy.

- Q: Should the price (noted as a percent of Medicare's price) for his MRI, colonoscopy, knee replacement or any other hospital services be the same as that of a healthy Hoosier?
- A: YES. Medicare pays more for people with comorbidities, so when we look at prices relative to Medicare, Bob being less healthy is already factored in.
 - The Relative Price for a commercial healthy Hoosier is compared to the price of healthy Medicare patient.
 - The Relative Prices for a commercial unhealthy Hoosier is compared to the price of an equally unhealthy Medicare patient.
 - Thus, comparing commercial prices relative to Medicare is fair way to compare apples to apples.

2020 FORUM INITIATIVES/TOPICS UNDER CONSIDERATION

Hospital price and quality transparency

Through benefit design to high value providers/hospital services

Rationale payment models to incent on low price and high quality

• Centers of Excellence, shared risk payment models, bundled payments for Episodes of Care, Tiered Network, Narrow Network, out-of-state options for health care

Wellness – keep people healthy and out of the hospital!

- Increase ACCESS to and reduce patient financial barrier to primary care and mental health providers
- Consider innovative or direct contracting and/or payment as a percent of Medicare to independent primary care providers, specialty care providers, and mental health providers.

2020 INITIATIVES/TOPICS UNDER CONSIDERATION

High Drug Prices

- Understanding relationship between 340B Pricing and Commercial Pricing
- Direct contracting with pharmacies
- Direct contracting with pharmaceutical companies for biosimilars & other meds
- Value-based drug formularies with 100% price transparency
- PBM and health plan contract optimization opportunities for employers

Advanced Care Planning

- Indiana is ranked lowest in the U.S. for having adequate services for the elderly...impacts retiree benefits
- Home health services versus costly hospital services
