Biographies

Christa-Marie Singleton

Dr. Christa-Marie Singleton is the Chief Medical Officer in CDC's Office of the Associate Director for Policy, and Strategy where she serves as the senior medical advisor regarding clinical to community population health interventions to improve health and control costs.

She represents CDC on the National Alliance of Healthcare Purchaser Coalitions' Board of Governors, as a Steering Committee Member for the Atlanta Regional Commission for Health Improvement, and served the CDC COVID-19 Response as a subject matter expert spokesperson and as the Associate Director for Science and Science Lead for the Chief Health Equity Office Unit.

Prior to joining OADPS, Dr. Singleton was the senior medical advisor in CDC's Division of State and Local Readiness where she was the lead architect of the inaugural edition of CDC's *Public Health Preparedness Capabilities: National Standards for State and Local Planning*.

Dr. Singleton has served as the chief medical director for the Baltimore City Health Department's Office of Public Health Preparedness and Response, the director of the Bureau of Disease Control at the Baltimore County Department of Health, and the senior analyst for maternal and child health at the Association of State and Territorial Health Officials. She has worked nights and weekends as a pediatric physician and is board certified in Public Health and General Preventive Medicine.

Dr. Singleton has been recognized by the White House Fellowship Program as a 1997 national finalist, received the 2011 "Outstanding Scientific Award" Employee of the Year Award by the Atlanta Federal Executive Board, and was selected to be a member of the 2020 class of the Nashville Health Care Council Fellows.

Jerome Adams

As the 20th U.S. Surgeon General and a prior member of the President's Coronavirus task force, Dr. Adams has been at the forefront of America's most pressing health challenges. A regular communicator via tv, radio, and in print, Dr. Adams is an expert not just in the science, but also in communicating the science to the lay public, and making it relevant to various audiences.

Dr. Adams is a licensed anesthesiologist with a master's degree in public health, and ran the Indiana State Department of Health prior to becoming Surgeon General. In the State Health Commissioner role he managed a \$350 million dollar budget and over 1000 employees, and led Indiana's response to Ebola, Zika, and HIV crises. Notably, Dr. Adams helped convince the Governor and State Legislature to legalize syringe service programs in the state, and to prioritize \$13 million in funding to combat infant mortality. As Surgeon General, Dr. Adams was the operational head of the 6000 person Public Health Service Commissioned Corps, and oversaw responses to 3 back to back category 5 hurricanes, and to a once in a century pandemic.

In addition to his recent COVID19 work, Dr. Adams has partnered with and assisted organizations as they

navigate the opioid epidemic, maternal health, rising rates of chronic disease, the impacts of rising suicide rates in our Nation, and how businesses can become better stewards and stakeholders in promoting community health.

Lana Dbeibo

Dr. Lana Dbeibo serves as Assistant Professor of Clinical Infectious Diseases at Indiana University School of Medicine and the Medical Director of Infection Prevention at Indiana University Health Methodist Hospital. Dr. Dbeibo is also a Master of Public Health student at the Richard Fairbanks School of Public Health at Indiana University and is a certified Implementation Science Scholar at Indiana University. She has been working in the field of quality and safety to improve patient outcomes in the hospitals for the past 5 years and has several publications that focus implementation of processes centered around reducing preventable harm to patients. Throughout the COVID pandemic, in addition to being part of the COVID response planning and policy development and implementation at IU Health, she has been a member of Indiana University's Medical Response Team and the Director of the COVID-vaccination initiatives for Indiana University across the state. She also led the training and deployment of Indiana University's medical students as part of the vaccination workforce throughout the state of Indiana. She has participated in numerous townhalls, webinars, and panel meetings to combat vaccine hesitancy throughout the state of Indiana and nationally, particularly with minoritized populations.

Tim Ingle

Tim is the Senior Vice President at Red Gold and the founder of the company's Business Leadership Team, which guides the company's overall sales, business strategy and operating philosophy to address business, operational, and employee needs. Tim reports to the CEO and plays the lead role in helping to chart the corporation's key organizational initiatives to attract, energize, and develop top talent across the company. He also leads the company's Business Improvement Strategy process, and serves as a key advisor on organizational values and engagement strategies across Red Gold's entire organization. In addition to Red Gold, Tim served as an Operations Manager for the Quaker Oats Company and spent four years of progressive responsibility with the Walt Disney World Company in Orlando, Florida.

A few of Tim's civic areas of involvement or distinction includes Board of Director of Folds of Honor Indiana, January 2020 to present, Teaching and Mentoring Communities – Board of Directors 2010- 2015; including the National "Plate of Bounty Award" in 2011 representing stewardship and leadership, Purdue University (West Lafayette & Distinguished Alumni, Anderson) – Academic Advisory Board Member, College of Technology (2005 – 2017); Distinguished Alumni, Anderson University Graduate School of Business 2010; USA Hockey Level 5 Masters' lifetime Coaching Certification; Madison County Leadership Academy Graduate (2000); Indiana Chamber of Commerce K-12 Education Committee, and Noblesville Preservation Alliance.

Tim earned a Bachelor of Science in Technology, Leadership, and Innovation from Purdue University, College of Technology in 1991 and later earned his Master's degree in Business Administration (MBA) in 1999 from Anderson University's Falls Graduate School of Business.
