Biographies

Chris Finelli

Chris Finelli is originally from Williamston, Michigan, and is a graduate of the University of Michigan. He also received the 2015 AHRQ Research Conference Director's Award for a paper published in JAMA Internal Medicine that examines the effect of reference pricing on consumer choice of providers for cancer screening services. Whaley received a B.A. in economics from the University of Chicago and a Ph.D. in health economics from the University of California, Berkeley.
