 - Provider capabilities vary from no electronic health record to very sophisticated systems

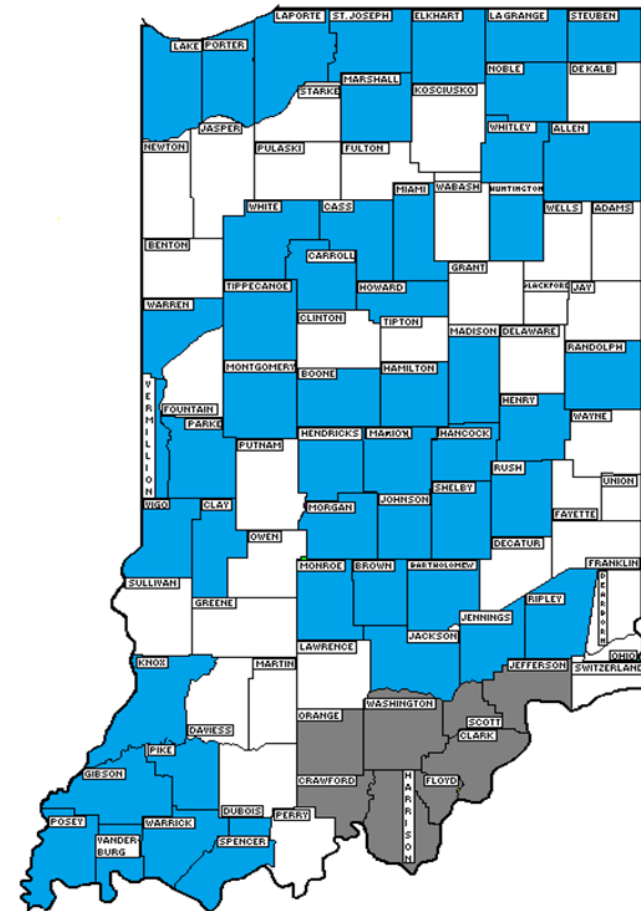


Accountable Care Organizations
