

History: Pharmacist Provided Clinical Services

Indian Health Service began incorporating clinical pharmacists in 1960

 1973, developed pharmacist practitioner program Veterans Affairs began incorporating clinical pharmacists in 1970s

 1995, permitted collaborative practice agreements with physicians. 2008 review article analyzed 93 pharmacist provided clinical services published studies including VA services

• ROI = 4.8:1

for every \$1 invested in clinical pharmacy services, \$4.8 of cost reduction achieved

2016, the VA had 7,700 clinical pharmacists practicing in ambulatory care, acute care, and residential care

over 5 million patient care visits annually

Integrated Health Systems: Geisinger Journey



In 1995, Geisinger started its first pharmacist-run anticoagulation clinic in Danville, PA



As of September 25, 2020,

58 primary care clinical pharmacists embedded in 51 sites across their system additional 20 clinical pharmacists in specialty medicine clinics



Medicare: Medication Therapy Management

CMS specifies Medication Therapy Management Service (MTMS) in detail

- MTM is a required benefit to be provided by all Part D Medicare Prescription Drug Plans (PDPs) since 2006 and must be offered to qualifying beneficiaries
- May (not must) be provided by a pharmacist

U.S. Congressional bill introduced April 2021 to recognize pharmacists as Medicare Part B providers
